### Members Meeting, Monday October 11<sup>th</sup>, 2021

**Polk County Auditor Jamie Fitzgerald** provided a summary of the main election law changes that related to: Voting in person; Absentee voting; requesting an Absentee Ballot; and a Transition Ballot.

He answered most of the questions from neighbors. He also said their website could answer most other questions.

As always, he was an informative and responsive guest.

**NBSD Officer Sgt. Scarlett** had indicated she would participate in this meeting and Dave Johnston was aware that our neighbor Rebekah Delgado was at this meeting specifically to talk with Sgt. Scarlett. When Jamie was finished, Dave interrupted the procedure to confirm that Rebekah was there specifically to talk with Sgt. Scarlett. He explained that it was unlikely she would show-up this late. Our City Inspector Josh Raleigh talked with Rebekah and confirmed the problem needed the police involvement. He volunteered to attempt to contact Sgt. Scarlett with the problem and a request for her to contact Rebekah. She was obviously frustrated and left the meeting.

**Inspector Josh Raleigh** updated the latest on “Blitz on Blight” explaining both homes of concern on Leach were scheduled for Demolition shortly. Josh had previously helped Jim and Roxanne with some neighbor problems. They expressed their appreciation for his efforts. There were some questions others had for Josh. He answered or indicated he would follow-up and get the answers.

**Joel Van Roekel** from Parks and Rec gave a general update and then answered several questions about the status of MacRae Park. Some indication that the Parks and Rec Department eventually wants to have a Park or Green Space within a Ten (10) minute walk from any resident’s home.

**Dave Johnston** update Neighbors regarding the following:
